Plan Year 2021 Registration and Training Is LIVE



Marketplace registration and training for plan year 2021 is starting today!

We recognize that agents and brokers are critical partners in the success of the Marketplace and encourage you to complete registration and training for plan year 2021 so you can help Marketplace consumers understand and find the coverage that fits their needs.

Follow these steps to complete registration and training:

1. [Log in](#) to the CMS Enterprise Portal
2. Update your information on your Marketplace Learning Management System (MLMS) agent/broker profile
3. Complete the Marketplace training requirement
4. Read and accept the applicable Marketplace Agreement(s)
5. Print your 2021 Registration Completion Certificate
6. Confirm your registration on using the [Registration Completion List](#)

Throughout the registration process, you can use the [Marketplace Registration Tracker](#) to track your progress.

You have options for completing your training. Training is offered by the Centers for Medicare & Medicaid Services (CMS) on the MLMS and through the CMS-approved vendor, [America's Health Insurance Plans](#),

[Inc. \(AHIP\)](#). AHIP offers Individual Marketplace training and may be able to offer you continuing education unit (CEU) credits, depending on the state in which you are licensed. Note: AHIP may charge a fee for its training. As in previous years, the MLMS-hosted training is free. Regardless of which training option you choose, you must return to the MLMS to complete your registration.

We strongly encourage you to complete registration and training as soon as possible to ensure you can successfully complete the process, which includes validation of your National Producer Number (NPN), before Open Enrollment starts on November 1. Don't delay – complete Marketplace registration and training today!
